Investigators from the San Diego Police Department's Robbery Unit are asking for the public's help in locating two suspects wanted for a commercial armed robbery of a Savers 99 Cents Store located in the Mid-City area of San Diego.

On December 13, 2017, at approximately 1:30 p.m., Irene Lee and Ariel Burrus walked into the Savers 99 Cents Store located at 4129 University Avenue, in San Diego. Lee shoplifted several items while Burrus acted as a lookout for her. Both suspects went to the checkout counter and Lee pretended as if she was going to pay for just one item. An employee blocked the exit of the store and demanded that Lee show him what she had taken. Neither Lee nor Burrus would cooperate. Burrus tried shoving her way past the employee, but was unsuccessful. Burrus then pulled out a small caliber revolver from the back of her waistband and pointed it at the back of the employee's head.

Burrus cocked back the hammer of the gun, and told the employee "let us go." The employee was able to turn, tackle Burrus to the ground, and took the gun away from her. Lee tried kicking the employee while he was on the ground. Burrus demanded the gun back and told the employee that she will come back and kill him. The employee held onto the gun and both suspects left the store before police officers arrived. Investigators were able to identify both suspects from evidence recovered at the scene.
