



## WANTED: Suspect in Commercial Robbery Series Up to \$1,000 Reward Offered

**San Diego County Crime Stoppers** and investigators from the San Diego Police Department's Robbery Unit along with investigators with the San Diego Sheriff's Department Rancho San Diego and Lakeside Stations are asking for the public's help to identify and locate an unknown male suspect wanted in connection with three commercial robberies.

On October 11, 2016, at 2:10 p.m., a male suspect walked into the CVS located at 6265 El Cajon Blvd., in San Diego. The male demanded cash from the clerk. The clerk did not immediately open the cash register. The suspect punched the clerk in the face resulting in a bloody nose. The suspect left without getting any money.

On October 11, 2016, at 6:00 p.m., the same suspect walked into the Taco Bell located at 2506 Jamacha Road, in the Rancho San Diego area. The suspect grabbed an employee and demanded that he open the register. The employee feared the suspect may have had a weapon and complied. The suspect stole an undisclosed amount of cash and left the store.

On October 11, 2016, at 6:55 p.m., the same suspect walked into the Jack in the Box located at 12155 Woodside Avenue, in Lakeside. The male told the staff that they were being robbed and demanded they open the cash register. An employee complied and the suspect left after stealing an undisclosed amount of cash.

### Suspect's Description:

The suspect is described as a White male, late 30's, 5'8" tall, 200 lbs, bald head, full goatee, and had a tattoo on one of his hands. He was seen driving a white Ford Ranger.
